# **Definitions**

For the purposes of this Privacy Policy:

Account means a unique account created for You to access the Service or parts of the Service.

- Affiliate means an entity that controls, is controlled by or is under common control with Us, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.
- HowDidItGo or Company and its Affiliate(s) (referred to as either "How", "the Company",
   "We", "Us" or "Our" in this Policy) refers to HowDidItGo, c/o 24 Webster Place Brookline,
   MA 02445, and its Affiliates, including Boston Vision, PLLC, 24 Webster Place Brookline,
   MA 02445.
- Cookies are small files that are placed on Your computer, mobile device or any other device
  by a website, containing the details of Your browsing history on that website among its many
  uses.
- Country refers to: United States
- Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- Personal Data is any information that relates to an identified or identifiable individual.
- Service refers to the Website.
- Service Provider means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, provide the Service on behalf of the Company, perform services related to the Service or to assist the Company in analyzing how the Service is used.
- Usage Data refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).
- User or Users refers to any user of the Service whether as a potential new patient or an existing or former patient participating in the Service.

COLLECTING AND USING YOUR PERSONAL DATA

Types of Data Collected

#### Personal Data

While using Our Service, We may ask You to provide Us with certain Personal Data that can be used to contact or identify You. Personal Data may include, but is not limited to:

Therefore, we cannot and do not guarantee that your User Contributions will not be viewed by unauthorized persons.

#### **Usage Data**

Usage Data is collected automatically when You are using the Service. Usage Data may include information such as Your Device's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that You visit, the time and date of Your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

The persons to whom the information in the preceding paragraph is disclosed may include medical companies who wish to receive such information to assist them in developing pharmaceutical and other products that may be useful in connection with the treatments in question. We will only provide de-identified data to such companies, i.e., data from which Your Personal Data has been removed or obscured, such that You cannot be directly or indirectly identified by the companies in question.
- To receive limited communications about the Services from medical companies. Provided that You give Your express consent to receive communications from medical companies by clicking on an "opt-in" checkbox or similar feature of the Website, we may send Your email address to such companies to enable them to contact You for purposes of requesting Your participation in surveys, research projects, and clinical studies, etc. If You opt-in, You may revoke Your consent at any time by clicking on an "opt-out" checkbox or similar feature of the Website.
- To attend and manage Your requests to Us.

- To contact You by email, telephone calls, SMS, or other equivalent forms of electronic communication, such as a mobile application's push notifications regarding updates or informative communications related to healthcare services, and functionalities, products or contracted services, when necessary or reasonable for their implementation.
- To provide You with general information about other services and events which we offer or
  other promotional emails that are similar to those that you have already purchased or inquired
  about unless You have opted not to receive such information and/or unsubscribed from such

## Limited Sharing of Your Information

We do not sell, lease, or rent your Personal Data to a third party for profit or other valuable consideration in a form in which You or Your information in your Personal Data may be identified; however, we reserve rights to sell, lease or rent Your data if rendered into a deidentified format. We may, however, share your Personal Data with selected third parties for our business purposes, including as set forth in this Privacy Policy. #### Retention of Your Personal Data

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will also retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if We are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

## Transfer of Your Personal Data

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. In addition, Our Service may give You the ability to delete certain information about You from within the Service. If so, You may update, amend, or delete Your Personal Data at any time by signing in to Your Account, if you have one, and visiting the account settings section that allows you to manage Your Personal Data. You may also contact Us to request access to, correct, or delete any Personal Data that You have provided to Us.
